**Mercia Ellis Bailey**  
**Case No. 2013-051380**

The Florida Board of Architecture and Interior Design agreed to enter a final order relinquishing Mercia Ellis Bailey's license to practice interior design. Ms. Bailey failed to timely respond to a continuing education audit.

**Georgia L. Carlee**  
**Case No. 2013-030184**

The Florida Board of Architecture and Interior Design agreed to enter a final order relinquishing Georgia L. Carlee's license to practice interior design. Ms. Carlee affirmed at renewal that she had completed the required continuing education credits. Ms. Carlee was chosen for the audit and has not provided any hours of continuing education during the audit period.

**Jorge C. Catalan**  
**Case No. 2013-039596**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$1,000.00 plus costs, forty hours of continuing education and suspension until compliance against Jorge C. Catalan's license to practice architecture. Mr. Catalan affirmed at renewal that he had completed the required continuing education credits. Mr. Catalan was chosen for the audit and has not provided any hours of continuing education.

**Case No. 2012-052922**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$1,000.00 plus costs, forty hours of continuing education and suspension until compliance against David M. Chason's license to practice interior design. Mr. Chason affirmed at renewal that he had completed the required continuing education credits. Mr. Chason was chosen for the audit and has not provided any hours of continuing education.

Mr. Joyner affirmed at renewal that he had completed the required continuing education credits. Mr. Joyner was chosen for the audit and has provided only eleven hours of continuing education.

**Case No. 2012-052961**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$1,000.00 plus costs, forty hours of continuing education hours and suspension until compliance against Jay Christopher Lovell's license to practice interior design. Mr. Lovell affirmed at renewal that he had completed the required continuing education credits. Mr. Lovell was chosen for the audit and has not provided any hours of continuing education.

**Case No. 2013-013569**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$1,500.00 plus costs against Rosario Salazar's license to practice interior design. Ms. Salazar is offering architectural services. Further, Ms. Rosario is offering interior design services through a business entity without a certificate of authorization.

**Case No. 2013-039606**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$1,000.00 plus costs, forty hours of continuing education hours and suspension until compliance against Donald P. Senatore's license to practice architecture. Mr. Senatore affirmed at renewal that he had completed the required continuing education credits. Mr. Senatore was chosen for the audit and has not provided any hours of continuing education.

**Arthur C. Shand**  
**Case No. 2013-030187**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$1,000.00 plus costs, forty hours of continuing education and suspension until compliance against Arthur C. Shand's license to practice interior design. Mr. Shand affirmed at renewal that he had completed the required continuing education credits. Mr. Shand was chosen for the audit and has not provided any hours of continuing education.

**Snyder Drafting Services, Inc.**  
**Robert L. Snyder**  
**Case No. 2012-040509**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$2,500.00 plus costs against Snyder Drafting Services, Inc. and Robert L. Snyder. Mr. Snyder is not licensed to practice architecture and provided architectural drawings for a commercial project. Further, Mr. Snyder is providing these services through a corporation without a certificate of authorization.

**Salvador E. Subira**  
**Case No. 2008-025280**

The Florida Board of Architecture and Interior Design agreed to enter a final order relinquishing Salvador E. Subira's license to practice architecture. Mr. Subira failed to timely respond to a continuing education audit.

**William M. Thompson**  
**Case No. 2013-051548**

The Florida Board of Architecture and Interior Design agreed to enter a final order relinquishing William M. Thompson's license to practice architecture. Mr. Thompson failed to timely respond to a continuing education audit.

**Gary Thresher**  
**Case No. 2013-008887**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$1,000.00 plus costs, forty hours of continuing education hours and suspension until compliance against Gary Thresher's license to practice architecture. Mr. Thresher affirmed at renewal that he had completed the required continuing education credits. Mr. Thresher was chosen for the audit and has not provided any hours of continuing education.

**Timothy Alan Wagoner**  
**Case No. 2013-030221**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$500.00 plus costs and eighteen hours of continuing education hours against Timothy Alan Wagoner's license to practice architecture. Mr. Wagoner affirmed at renewal that he had completed the required continuing education credits. Mr. Wagoner was chosen for the audit and has provided only twelve hours of continuing education.

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$750.00 plus costs and twenty-six hours of continuing education hours against Marc E. Walk's license to practice architecture. Mr. Walk affirmed at renewal that he had completed the required continuing education credits. Mr. Walk was chosen for the audit and has provided only nine hours of continuing education.
