Case No. 2011-045532

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$10,000.00 plus costs against Archidesign, Inc. and Humberto A. Acosta, Jr. Mr. Acosta is not licensed to practice architecture in the State of Florida and doing business as Archidesign, Inc. Also, Mr. Acosta is offering architectural services on its website.

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$5,000.00 plus costs against John Bannick and JOHNVARR Construction and Consulting, Inc. John Bannick and JOHNVARR Construction and Consulting, Inc. are not licensed to practice architecture in the State of Florida and Mr. Bannick is using the title architect.

Conrad Augusto Bonet
Case No. 2013-030178

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$1,000.00 plus costs, forty hours of continuing education hours and suspension until compliance against Conrad Augusto Bonet's license to practice interior design. Mr. Bonet affirmed at renewal that he had completed the required continuing education credits. Mr. Bonet was chosen for the audit and has not provided any hours of continuing education.

Aaron S. Cohen

Ms. Haude affirmed at renewal that she had completed the required continuing education credits. Ms. Haude was chosen for the audit and has provided only eighteen hours of continuing education.

Jeffrey S. Hindman
Case No. 2012-052942

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$750.00 plus costs and twenty-two hours of continuing education hours against Jeffrey S. Hindman's license to practice architecture. Mr. Hindman affirmed at renewal that he had completed the required continuing education credits.
