Emilio Jose Agrenot
Emilio Jose Agrenot, P.A.
Case No. 2012-049065

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$1,000.00 plus costs and four years probation against Emilio Jose Agrenot’s license to practice architecture. Mr. Agrenot failed to perform under a contract to provide permit ready drawings.

Dave Wainscott Designs

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$5,000.00 plus costs against Dave Wainscott Design and Dave Wainscott. Dave Wainscott Designs and Dave Wainscott are not licensed to practice architecture and are offering architectural services on their website and in their proposals.

Farley Engineering, LLC
Frank W. Farley

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$500.00 plus costs against Farley Engineering, LLC and Frank W. Farley. Farley Engineering, LLC and Frank W. Farley are not licensed to practice architecture; however Mr. Farley is a licensed Professional Engineer. Mr. Farley is practicing architecture without a certificate of authorization.

Scotty Allen Ford
Case No. 2013-031705

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$1,000.00 plus costs, forty hours of continuing education hours and suspension until compliance against Scotty Allen Ford’s license to practice architecture. Mr. Ford affirmed at renewal that he had completed the required continuing education credits. Mr. Ford was chosen for the audit and has not provided any hours of continuing education.

Jorge A. Gamarra
Case No. 2013-039585

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a costs and twenty-seven hours of continuing education against Jorge A. Gamarra's license to practice architecture. Mr. Gamarra affirmed at renewal that he had completed the required continuing education credits. Further, Mr. Griffin contracted to provide permit ready drawings for two residential projects Mr. Griffin was paid for both projects but failed to provide the drawings.

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$750.00 plus costs and twenty-seven hours of continuing education hours against Gerald A. Johnson's license to practice interior design. Mr. Johnson affirmed at renewal that he had completed the required continuing education credits. Mr. Johnson was chosen for the audit and has provided only eight hours of continuing education.

G. Franklin Lee

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$1,000.00 plus costs, forty hours of continuing education hours and suspension until compliance against G. Franklin Lee's license to practice architecture. Mr. Lee affirmed at renewal that he had completed the required continuing education credits. Mr. Lee was chosen for the audit and has not provided any hours of continuing education.

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$250.00 plus costs and eight hours of continuing education against Peter Morgan Pennoyer's license to practice architecture. Mr. Pennoyer affirmed at renewal that he had completed the required continuing education credits. Mr. Pennoyer was chosen for the audit and has provided only seventeen hours of continuing education.
