**Ariel Aljovin**  
**Case No. 2014-012674**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$1,000.00 plus costs against Ariel Aljovin. Mr. Aljovin is not licensed to practice architecture and is contracting and providing architectural services for commercial projects.

**Base 4 International, Inc.**  
**Adam J. Ginsburg**  
**Case No. 2013-048347**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$1,000.00 plus costs against Base 4 International, Inc. and Adam J. Ginsburg. Base 4 International, Inc. and Adam J. Ginsburg are not licensed to practice architecture and are offering architectural services and are using the title architect on its web site. The web site also refers to two commercial projects in the State of Florida. Further, Mr. Ginsburg is offering these services through a corporation without a certificate of authorization.

The Florida Board of Architecture and Interior Design agreed to enter a final order accepting a voluntary relinquishment of Drafting Design Service, Inc.’s license to practice architecture.

**Mary Beth Courier**  
**Oxford Design Studio**  
**Case No. 2013-041554**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$5,000.00 plus costs against Mary Beth Courier and Oxford Design Studio. Mary Beth Courier and Oxford Design Studio are not licensed to practice architecture and are contracting to provide interior design services on commercial projects and are offering commercial interior design services on its web site. Further, Ms. Courier is offering these services through a corporation without a certificate of authorization.

**Carrie A. Cox**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a reprimand plus costs against Carrie A. Cox's license to practice interior design. Ms. Cox is attempting to provide responsible supervisory control over a Florida office while maintaining a residence out of state.

**Michael E. Craddock**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$500.00 plus costs against Michael E. Craddock. Mr. Craddock was previously licensed; however, his license went delinquent on March 1, 2003, and then into a null and void status on March 1, 2005. Mr. Craddock practiced architecture, held himself out as an architect and used his null and void license number.

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$500.00 plus costs against Creative Architectural Design Consultant, Inc. and Jason A. Rohr. Jason A. Rohr is doing business as Creative Architectural Design Consultants, Inc., holding himself as an architect and offering architectural services on his web site. Further, Mr. Rohr is offering these services through a corporation without a certificate of authorization.

**Pierto D'Aleo**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$1,000.00 plus costs and thirty two hours of continuing education against Pierto D'Aleo's license to practice architecture. Mr. D'Aleo affirmed at renewal that he had completed the required continuing education credits. Mr. D'Aleo was chosen for the audit and has only provided 3 hours of continuing education.

Further, Ms. Krause is offering these services through a business entity without a certificate of authorization.

The Florida Board of Architecture and Interior Design agreed to enter a final order accepting a voluntary relinquishment of DKOR Interiors, Inc.'s license to practice interior design.

**Fernando R. Gomez-Pina**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$1,000.00 plus costs against Fernando R. Gomez-Pina. Fernando R. Gomez-Pina is not licensed to practice architecture; however he is a licensed Professional Engineer and he signed and sealed drawings for a barber shop which included architectural drawings.

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing costs and forty hours of continuing education against Aldo P. Lastra's license to practice architecture. Mr. Lastra affirmed at renewal that he had completed the required continuing education credits. Mr. Lastra was chosen for the audit and has not provided any hours of continuing education.

Mothe Design, Inc. and Raquel Mothe are not licensed to practice architecture and are offering architectural services on its web site and appears to have provided work on commercial projects. Further, Ms. Mothe is offering these services through a corporation without a certificate of authorization.

**Lifestyle Design Studio**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$1,500.00 plus costs against Daniel R. Mueller and Lifestyle Design Studio. Daniel R. Mueller and Lifestyle Design Studio are not licensed to practice architecture in the State of Florida; however Mr. Mueller is licensed in Virginia and Maryland. Mr. Mueller is contracting to provide architectural drawings for a residential project, using the title architect and offering architectural services on his web site.

**Eduardo Poveda**  
**Poveda Designs, Inc.**  
**Case No. 2013-035500**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$2,500.00 plus costs against Eduardo Poveda and Poveda Designs, Inc. Eduardo Poveda and Poveda Designs, Inc. are not licensed to practice architecture and provided architectural services for a clubhouse and is offering architectural services on his web site. Further, Mr. Poveda is offering these services through a corporation without a certificate of authorization.

**SAG Group, Inc.**

**Case No. 2013-049942**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a reprimand plus costs against SAG Group, Inc.'s license to practice architecture. Mr. Salazar signed and sealed plans for a project in which a licensed interior design firm had the contract with the client to perform architectural services.

**Susan L. Sharp**

The Florida Board of Architecture and Interior Design agreed to enter a final order accepting a voluntary relinquishment of Susan L. Sharp's license to practice architecture.

**Gary Thresher**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing suspension until compliance against Gary Thresher's license to practice architecture. Mr. Thresher was issued a citation for failing to reply to the continuing education audit and has not paid the fine.

Tondre Interiors Design Studio, Inc. and Eugene Tondre are not licensed to practice architecture and are offering interior design services in an advertisement. Mr. Tondre claims to have state licensure and is offering commercial design work.

**William Edwin Wallace**  
**Case No. 2014-002628**

The Florida Board of Architecture and Interior Design agreed to enter a final order accepting a voluntary relinquishment of William Edwin Wallace's license to practice interior design.

**James D. Woody**  
**Weber Design Group, Inc.**  
**Case Nos. 2013-030884 & 2013-030890**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine plus costs, two years probation and one year suspension against James D. Woody and Weber Design Group, Inc.'s license to practice architecture. Mr. Woody attempted to provide responsible supervisory control over an office in Naples, Florida while living in Fairfax, Virginia.
