**Design Pros**  
**Barry Webb**  
**Case No. 2021-005029**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$3,000.00 plus costs against Design Pros and Barry Webb. Mr. Webb and the company are not licensed to practice architecture and are offering architectural services on their website.

**Designwest Associates**  
**Case No. 2020-017041**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$3,000.00 plus costs against Designwest Associates. Designwest Associates is not licensed to practice architecture and contracted to provide architectural drawings for a 5-unit multifamily building.

**Gabriel Dziekiewicz**  
**Case No. 2020-039747**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing costs and 10.25 hours of continuing education against Gabriel Dziekiewicz’s license to practice architecture. Mr. Dziekiewicz affirmed at renewal that he had completed the required hours and only provided 19.75 hours of continuing education during the audit period.

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$5,000.00 plus costs against Wayne Gandy and Design Engineering, LLC. Mr. Gandy and the company are not licensed to practice architecture; however Mr. Gandy is a licensed professional engineer. Mr. Gandy is aiding and abetting an unlicensed individual to engage in the practice of architecture.

**Ramon Garcia**  
**Case No. 2020-027834**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$2,500.00 plus costs against Ramon Garcia. Mr. Garcia is not licensed to practice architecture and is offering architectural services in his business name and using the designation AIA.

**Dana Mufson**  
**Case No. 2020-032782**

The Florida Board of Architecture and Interior Design agreed to enter a final order accepting a voluntary relinquishment of Dana Mufson's license to practice interior design.

**David Perkins**  
**Case No. 2020-000205**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing \$300.00 in costs and suspension until compliance against David Perkins' license to practice architecture. Mr. Perkins failed to provide proof of the required continuing education requirements and pay the fines and costs totaling \$1,232.50 required by the Final Order entered on February 19, 2019.

**Daniel Robertson**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing a fine of \$750.00 plus costs and 33 hours of continuing education against Daniel Robertson's license to practice architecture. Mr. Robertson affirmed at renewal that he had completed the required hours and only provided 9 hours of continuing education during the audit period.

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$2,500.00 plus costs against Joseph Simmons. Mr. Simmons is not licensed to practice architecture and entered into a contract to provide architectural services for a church project and is using the title architect.

**John Summitt**  
**Case No. 2020-055549**

The Florida Board of Architecture and Interior Design agreed to enter a final order approving a settlement stipulation imposing 21 hours of continuing education against John Summitt's license to practice architecture. Mr. Summitt affirmed at renewal that he had completed the required hours and only provided 3 hours of continuing education during the audit period.

**Guy Tetrick**

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$2,500.00 plus costs against Guy Tetrick. Mr. Tetrick is not licensed to practice architecture and contracted to provide architectural services and is using the title architect.

The Florida Board of Architecture and Interior Design agreed to enter a final order imposing a fine of \$500.00 plus costs and 23.5 hours of continuing education against Leif Eric Widholm's license to practice architecture. Mr. Widholm affirmed at renewal that he had completed the required hours and only provided 12.5 hours of continuing education during the audit period.
