all of that certain real property located in Leon County, Florida,
more particularly described in Exhibit A attached hereto and made
a part hereof; and

WHEREAS, said property has been developed into twenty-
nine townhouse sites suitable for construction of residential
dwellings thereon, together with appropriate easements for
pedestrian and vehicular ingress and egress, and utilities, in
the form of an unrecorded subdivision development; and

WHEREAS, DIAMONDHEAD, a Florida general partnership,
has acquired nine of said townhouse sites and constructed dwellings
thereon; and

WHEREAS, DIAMONDHEAD, a Florida general partnership,
did cause to be filed a Declaration of Covenants, Conditions and






I hereby certify that this is a true and accurate representation of the following described property to the best of my knowledge and belief.

The undersigned surveyor has not been provided a current title opinion or abstract of matters affecting title or boundary to the subject property. It is possible there are deeds of record, unrecorded deeds, easements or other instruments which could affect the boundaries.

Commence at the Northeast corner of Winewood South Unit No. 2, as recorded in Plat Book 8, Page 32 of the Public Records of Leon County, Florida, and run West along the North boundary of said Winewood South Unit No. 2 a distance of 158.09 feet to the POINT OF BEGINNING. From said POINT OF BEGINNING continue West along said North boundary and a projection thereof a distance of 399.14 feet, thence North 46 degrees 40 minutes 29 seconds East along the boundary of Winewood Golf Course 510.10 feet, thence South 54 degrees 09 minutes 44 seconds East along said boundary 111.02 feet, thence South 18 degrees 38 minutes 30 seconds East along said boundary 284.95 feet, thence West along a line 15 feet North of and parallel with said North boundary of Winewood South Unit No. 2 a distance of 158.09 feet, thence South 18 degrees 38 minutes 30 seconds East 15.83 feet to the POINT OF BEGINNING; containing 2.41 acres, more or less.
