HARTSFIELD WOODS


KNOW ALL MEN BY THESE PRESENTS, that this Amendment to Declaration of Covenants, Conditions and Restrictions, made and entered into this 23rd day of April, 1984, by EQUITY RESOURCES, INC., a Florida corporation, hereinafter called "Developer" and PACIFIC PETROLEUM, INC., a Florida corporation, ALBERT SMELKO, JR., and DAL BUILDERS, INC., a Florida corporation, hereinafter called "Owners";

W I T N E S S E T H :

WHEREAS, Developer and Owners constitute all property owners of that certain real property commonly known as HARTSFIELD WOODS and desire to amend the original Declaration of Covenants, Conditions and Restrictions dated June 11, 1983, and recorded in Official Records Book 1086, Page 2312 of the Public Records of Leon County, Florida, to include a legal description of additional Common Areas which was inadvertently omitted from said original restrictions;

NOW, THEREFORE, the Developer and Owners declare that Article I, Section 4, Common Areas shall be amended to include that certain property described in Exhibit "A" attached hereto and by reference made a part hereof, and that any reference to Common Areas shall heretofore be interpreted to include all of those areas described in the original Declaration of Covenants, Conditions and Restrictions referred to herein as well as those areas described in Exhibit "A" attached hereto.

The parties hereto agree that the Covenants, Conditions and Restrictions, as amended and modified herein, are hereby ratified, confirmed and declared valid in all respects and are now in full force and effect.


