E A S E M E N T

KNOW ALL MEN BY THESE PRESENTS

That, for valuable consideration hereby acknowledged, the undersigned hereby grants and conveys unto Southeastern Telephone Company, its successors and assigns forever, a right of way easement to construct, install, operate, maintain, replace and remove a communication system consisting of such towers, poles, fixtures, guys, anchors, wires, cables, buried cables, buried wires, posts, terminals, location markers, manholes, conduits, phone booths and other appurtenances, as the grantee may, from time to time require upon, under, across and over certain land owned by the grantor or in which the grantor has an interest, situated in the County of Leon, in the State of Florida, and more particularly described as follows: (Give width and location of easement strip.)
