WHEREAS, Developer pursuant to Article IV of Declaration of Covenants and Restrictions of Meridian Hills reserved the power to assign and to amend the covenants and restrictions for the purpose of curing any ambiguity in or any inconsistency between the provisions contained therein, and;

WHEREAS, Developer has never heretofore released its power to assign and to amend the declaration of covenants and restrictions of Meridian Hills, and;

WHEREAS, Meridian Hills Neighborhood Association, Inc., is a Florida corporation qualified under Article IV of the Declaration of Covenants and Restrictions of Meridian Hills as the homeowners association described therein.


**ASSIGNMENT**
