**I. Unlicensed Cases**

**3DCADCO, Inc.**  
**Jon Sage**  
**Case No. 2012-048450**

Probable cause was found that 3DCADCO and Jon Sage of Miami, FL, are not licensed to practice architecture in Florida and are offering architectural services on its website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Sage sign an affidavit stating he has changed his website and will not offer such services in the future. If Mr. Sage fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Archidesign, Inc.**  
**Humberto A. Acosta, Jr.**  
**Case No. 2011-045532**

Probable cause was found that Archidesign, Inc. and Humberto A. Acosta, Jr., of Miami, FL, are not licensed to practice architecture in Florida and are offering architectural services on its website. Further, Mr. Acosta is doing business as Archidesign, Inc. An Administrative Complaint seeking fines will be filed.

**Ardenix Design Group**  
**Isaac M. West**  
**Case No. 2012-027097**

Probable cause was found that Ardenix Design Group and Isaac M. West of Orlando, FL, are not licensed to practice architecture in Florida and are offering architectural services on its website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. West sign an affidavit stating he has changed his website and will not offer such services in the future. If Mr. West fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**ART & STYLO, Inc.**  
**Ravaal Almada**  
**Case No. 2012-048450**

Probable cause was found that ART & STYLO and Ravaal Almada of Miami, FL, are not licensed to practice architecture in Florida and are offering architectural services on a flyer. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Almada sign an affidavit stating he has changed his advertisements and will not offer such services in the future. If Mr. Almada fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Avant Design Group**  
**Cristina Souza**  
**Case No. 2012-028987**

Probable cause was found that Avant Design Group and Cristina Souza of Miami, FL, are not licensed to practice architecture in Florida and are offering architectural detailing and commercial interior design services on its website. A Notice and Order to Cease and Desist from offering architectural or interior design services was issued along with the requirement that Ms. Souza sign an affidavit stating she has changed her website and will not offer such services in the future. If Ms. Souza fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**James F. Biagi**  
**Case No. 2011-046910**

Probable cause was found that James F. Biagi of Ft. Lauderdale, FL, is not licensed to practice architecture in Florida; however he is a licensed Professional Engineer. Mr. Biagi provides services for an unlicensed firm that is offering architectural services. An Administrative Complaint seeking fines will be filed.

**Brad Design & Engineering, Inc.**  
**Vince Bradley**  
**Case No. 2012-025932**

Probable cause was found that Brad Design & Engineering, Inc. and Vince Bradley of Brandon, FL, are not licensed to practice architecture; however they are a licensed engineering firm in Florida. The firm is offering architectural services on its website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Bradley sign an affidavit stating he has changed the firm's website and will not offer such services in the future. If Mr. Bradley fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Cannatelli Builders, Inc.**  
**Edward D. Cannatelli**  
**Case No. 2011-056898**

Probable cause was found that Cannatelli Builders, Inc. and Edward D. Cannatelli of Pompano Beach, FL, are not licensed to practice architecture in Florida and are offering architectural services. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Cannatelli sign an affidavit stating that he will not offer such services in the future. If Mr. Cannatelli fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Concept Design Group, LLC**  
**Olga T. Morales**  
**Case No. 2012-025682**

Probable cause was found that Concept Design Group, LLC and Olga T. Morales of Miramar, FL, are not licensed to practice architecture in Florida and prepared a proposal to provide architectural services for an apartment complex. Further, Ms. Morales is offering these services through a business entity without a certificate of authorization. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Ms. Morales sign an affidavit stating she will not offer such services in the future. If Ms. Morales fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Alan C. Dobbs**  
**Florida Design Studio, Corp.**  
**Case No. 2013-002610**

Probable cause was found that Alan C. Dobbs and Florida Design Studio, Corp. of Tampa, FL, are not licensed to practice architecture in Florida and are offering architectural services on its website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Dobbs sign an affidavit stating he has changed his website and will not offer such services in the future. If Mr. Dobbs fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Angel E. Guerrero**  
**Case No. 2012-027051**

Probable cause was found that Angel E. Guerrero of Jacksonville, FL, is not licensed to practice architecture in Florida and is offering architectural services. Further, Mr. Guerrero is holding himself out as an architect. An Administrative Complaint seeking fines will be filed and a Notice and Order to Cease and Desist will be issued.

**Carlos Gutierrez**  
**Milda Gutierrez**  
**CMGINTG, Inc.**  
**Case Nos. 2012-026888**  
**2012-028674**

Probable cause was found that Carlos Gutierrez, Milda Gutierrez and CMGINTG, Inc., of Miami, FL, are not licensed to practice architecture in Florida and are using the title architect and contracting for architectural services. Mr. and Ms. Gutierrez are offering these services through a corporation with out a certificate of authorization. An Administrative Complaint seeking fines will be filed and a Notice and Order to Cease and Desist will be issued.

**Kyle Hauser**  
**Case No. 2012-049771**

Probable cause was found that Kyle Hauser of Austin, TX, is not licensed to practice architecture in Florida and is offering architectural services on his website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Hauser sign an affidavit stating he has changed his website and will not offer such services in the future. If Mr. Hauser fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Judith Liegeois**  
**Judith Liegeois Design, Inc.**  
**Case No. 2013-013310**

Probable cause was found that Judith Liegeois and Judith Liegeois Design, Inc. of Naples, FL, are not licensed to practice architecture in Florida and are offering architectural services on a flyer. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Ms. Liegeois sign an affidavit stating she has changed her advertisements and will not offer such services in the future. If Ms. Liegeois fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Michael Dawkins Home**  
**Michael Dawkins**  
**Case No. 2012-048901**

Probable cause was found that Michael Dawkins Home and Michael Dawkins of Miami, FL, are not licensed to practice architecture in Florida and are offering architectural services on its website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Dawkins sign an affidavit stating he has changed his website and will not offer such services in the future. If Mr. Dawkins fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Mauricio Pampillo**  
**Project Architecture Group Company**  
**Case Nos. 2011-034567**  
**2012-031017**

Probable cause was found that Mauricio Pampillo and Project Architecture Group Company of Miami, FL, are not licensed to practice architecture in Florida and are contracted to provide signed and sealed drawings for two projects. Further, Mr. Pampillo is doing business as Project Architecture Group and is offering these services through a business entity without a certificate of authorization. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Pampillo sign an affidavit stating he will not offer such services in the future. If Mr. Pampillo fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Roof Resources, Inc.**  
**Richard T. Dolgin**  
**Case No. 2012-048901**

Probable cause was found that Roof Resources, Inc. and Richard T. Dolgin of Palm Coast, FL, are not licensed to practice architecture in Florida and are offering architectural services on its website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Dolgin sign an affidavit stating he has changed his website and will not offer such services in the future. If Mr. Dolgin fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Robert Wiesner**  
**Case No. 2012-026826**

Probable cause was found that Robert Wiesner of Cape Coral, FL, is not licensed to practice architecture in Florida and is using the title architectural drafter. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Wiesner sign an affidavit stating he has changed his title and will not offer such services in the future. If Mr. Wiesner fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

**Ivan D. Vanegas**  
**Case No. 2011-061017**

Probable cause was found that Ivan D. Vanegas of Pompano Beach, FL, is not licensed to practice architecture in Florida and is using the title architect. An Administrative Complaint seeking fines will be filed and a Notice and Order to Cease and Desist will be issued.

## **II. Licensed Cases**

### **Ali Ajalli**

**Case No. 2012-052921**

Probable cause was found that Ali Ajalli of McLean, VA, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. Ajalli was chosen for the audit and has provided only 13 hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.

### **David C. Baum**

**Case No. 2012-052769**

Probable cause was found that David C. Baum of Milwaukee, WI, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. Baum was chosen for the audit and provided 20 hours of continuing education; however he did not complete the building code course. An Administrative Complaint seeking discipline will be filed.

### **Donald A. Dicomio**

**Case No. 2013-008927**

Probable cause was found that Donald A. Dicomio of Livonia, MI, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. Dicomio was chosen for the audit and has not provided any hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.

### **Paul A. Donofro**

**Case No. 2012-052925**

Probable cause was found that Paul A. Donofro of Mariana, FL, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. Donofro was chosen for the audit and has not provided any hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.

### **Faulkner Eyo**

**Case No. 2012-044698**

Faulkner Eyo is licensed to practice architecture in the State of Florida and provided three projects during the course of probation which were insufficient. An Administrative Complaint seeking discipline will be filed.

### **Michael T. Foster**

**Case No. 2012-052926**

Probable cause was found that Michael T. Foster of Arlington, VA, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. Foster was chosen for the audit and has not provided any hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.

**James Charles Griffin**  
**Case Nos. 2012-027232**  
**2012-035638**  
**2012-042947**

Probable cause was found that James Charles Griffin of Parkland, FL, is licensed to practice architect in the State of Florida and failed to comply with a Final Order that requires payment of fines and completion of the Florida Building Code Course. Further, Mr. Griffin contracted to provide permit ready drawings for two residential projects, which he was paid for but failed to provide the drawings. An Administrative Complaint seeking discipline will be filed.

**Jaime R. Gutierrez**  
**Case No. 2012-027721**

Jaime R. Gutierrez is licensed to practice architecture in the State of Florida and signed and sealed plans for a project that were prepared by an unlicensed draftsman without ever meeting with the client. Further, Mr. Gutierrez has been unable to provide the proper documentation for signing and sealing drawings that were prepared outside his office. An Administrative Complaint seeking discipline will be filed.

**Jeffrey S. Hindman**  
**Case No. 2012-052942**

Probable cause was found that Jeffrey S. Hindman of Sarasota, FL, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. Hindman was chosen for the audit and has provided only 7 hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.

**Harry J. Howard**  
**Case No. 2012-052952**

Probable cause was found that Harry J. Howard of Tampa, FL, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. Howard was chosen for the audit and has not provided any hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.

**Betsy Isackson**  
**Case No. 2012-052954**

Probable cause was found that Betsy Isackson of Delray Beach, FL, a Florida licensed interior designer, affirmed at renewal that she had completed the required continuing education credits. Ms. Isackson was chosen for the audit and provided only 18 hours of continuing education and did not complete the building code course. An Administrative Complaint seeking discipline will be filed.

**Ronald Martin McFarland**  
**Case No. 2012-052787**

Probable cause was found that Ronald Martin McFarland of Oakland, TN, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. McFarland was chosen for the audit and has provided only 12 hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.

**Richard Glen Moore**  
**Case No. 2012-052965**

Probable cause was found that Richard Glen Moore of Hawthorne, FL, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. Moore was chosen for the audit and has not provided any hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.

**Kristi A. Munilla**  
**Case No. 2013-005031**

Probable cause was found that Kristi A. Munilla of Miami, FL, a Florida licensed interior designer, affirmed at renewal that she had completed the required continuing education credits. Ms. Munilla was chosen for the audit and has not provided any hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.

**Juan A. Rodriguez-Jomolca**  
**Juan A. Rodriguez-Jomolca Architect, PA**  
**Case No. 2011-018728**

Juan A. Rodriguez-Jomolca is licensed to practice architecture in the State of Florida and signed and sealed deficient plans. An Administrative Complaint seeking discipline will be filed.

**Angel C. Saqui**  
**Case No. 2012-052983**

Probable cause was found that Angel C. Saqui of Coral Gables, FL, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. Saqui was chosen for the audit and has provided only 15.5 hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.
