If Ms. Cavallo fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

Probable cause was found that Todd Emmons and Todd Emmons, Inc. of Hudson, FL, are not licensed to practice architecture in Florida and are offering architectural services on thier web site. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Emmons sign an affidavit stating he changed his web site and will not offer such services in the future. If Mr. Emmons fails to return the affidavit, an Administrative Complaint seeking fines will be filed.
