#### I. Unlicensed Cases

Darisley Arcia Nova Homes of Southwest Florida Case No.: 2025-059882

2025-059889

Probable cause was not found that Darisley Arcia and Nova Homes of Southwest Florida are using the title architect without a license. A Closing Order was issued.

**Quincy Brown** 

Case No.: 2025-061949

Probable cause was found that Quincy Brown is not licensed to practice architecture in Florida and is offering architectural services in an email solicitation. A Notice and Order to Cease and Desist from offering architectural services in the State of Florida was issued along with the requirement that Mr. Brown sign an affidavit stating he will not offer or provide architectural services in the State of Florida. If Mr. Brown fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

#### Luis Canelas

Case No.: 2024-038017

Probable cause was found that Luis Canelas of West Palm Beach, FL, is not licensed to practice architecture in Florida and contracted to provide signed and sealed architectural drawings. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Canelas sign an affidavit stating he will not offer or provide architectural services in the State of Florida. If Mr. Canelas fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

# Clavel Arquitectos Case No.: 2025-052582

Probable cause was found that Clavel Arquitectos is a Spanish architectural firm which is not licensed to practice architecture in Florida. The company is offering architectural services from a Florida address on its web site. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that they sign an affidavit stating they will not offer or provide architectural services in the State of Florida. If they fail to return the affidavit, an Administrative Complaint seeking fines will be filed.

Derek Cronin Cronin Engineering Case No.: 2025-034140

2025-034145

Probable cause was not found that Derek Cronin and Cronin Engineering signed and sealed a set of residential plans. A Closing Order was issued.

**Archer Davis** 

Case No.: 2025-053678

Probable cause was found that Archer Davis is not licensed to practice architecture in Florida and is offering architectural services in an email solicitation. A Notice and Order to Cease and Desist from offering architectural services in the State of Florida was issued along with the requirement that Mr. Davis sign an affidavit stating he will not offer or provide architectural services in the State of Florida. If Mr. Davis fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

Ulises De Llano Granados ULI Architects Case No.: 2025-042665

2025-042668

Probable cause was found that Ulises De Llano Granados and ULI Architects of Mexico, are not licensed to practice architecture in Florida and are offering architectural services on their website. A Notice and Order to Cease and Desist from offering architectural services in the State of Florida was issued along with the requirement that Mr. De Llano Granados sign an affidavit stating he will not offer or provide architectural services in the State of Florida. If Mr. De Llano Granados fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

Jimmy Dean Naples Custom Design Case No.: 2025-052956 2025-052957

Probable cause was found that Jimmy Dean and Naples Custom Design of Naples, FL, are not licensed to practice architecture in Florida and contracted to provide signed and sealed drawings. An Administrative Complaint seeking fines will be filed.

Marc Devisse Tri Town Construction Case No.: 2025-034128 2025-034120

Probable cause was not found that Marc Devisse and Tri Town Construction are offering architectural services. A Closing Order was issued.

Michelle Dinardi-Rice Case No.: 2025-015275

Probable cause was not found that Michelle Dinardi-Rice is using the title architect without a license. A Closing Order was issued.

Stephen Gaydosh Case No.: 2025-058014

Probable cause was found that Stephen Gaydosh of Vero Beach, FL, is not licensed to practice architecture in Florida however he is a former Professional Engineer whose license has been revoked. Mr. Gaydosh is contracting to provide signed and sealed drawings and is using the license of an architect without his knowledge. An Administrative Complaint seeking fines will be filed.

Miguel Angel Gonzalez Inmobiliare, LLC Stanczyk-Gonzalez Case No.: 2025-044751 2025-044758

2025-044763

Probable cause was found that Miguel Angel Gonzalez, Inmobiliare, LLC and Stanczyk-Gonzalez of Miami, FL, are not licensed to practice architecture in Florida and entered into a contract to provide architectural services. Further, Mr. Gonzalez is using the title architect. An Administrative Complaint seeking fines will be filed.

Miguel Guillen

Case No.: 2024-065706

Probable cause was not found that Miguel Guillen entered a verbal contract to provide architectural services. A Closing Order was issued.

Doug Hendricks Gulfside Carpentry, LLC Case No.: 2025-055135 2025-055139

Probable cause was found that Doug Hendricks and Gulfside Carpentry, LLC of Palm Harbor, FL, are not licensed to practice architecture in Florida and are contracting to provide signed and sealed drawings and is offering architectural services in his contract. An Administrative Complaint seeking fines will be filed.

**Daniyal Hussain** 

Grace Architecture & Estimating, LLC

Case No.: 2025-048758 2025-048745

Probable cause was found that Daniyal Hussain and Grace Architecture & Estimating, LLC of Severn, MD, are not licensed to practice architecture in Florida and is sealing residential plans that contain the signature and seal of a Florida licensed architect who has no knowledge of the project. An Administrative Complaint seeking fines will be filed.

Kelsie Jablonski Kelmic Design Group, LLC Case No.: 2025-052308 2025-052313

Probable cause was found that Kelsie Jablonski and Kelmic Design Group, LLC of Lakeland, FL, are not licensed to practice architecture in Florida and are offering architectural services. Further, Mr. Jablonski is using the title architect. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Jablonski sign an affidavit stating he will not offer or provide architectural services in the State of Florida. If Mr. Jablonski fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

Victor Lee Mabire House Plans Unlimited Case No.: 2025-015441 2025-015440

Probable cause was found that Victor Lee Mabire and House Plans Unlimited of Pensacola, FL, are not licensed to practice architecture in Florida and are offering architectural services in an advertisement and using some type of seal on residential plans. An Administrative Complaint seeking fines will be filed.

David Martin

Case No.: 2025-048771

Probable cause was found that David Martin of Severn, MD, is not licensed to practice architecture in Florida and is offering architectural services in an email. A Notice and Order to Cease and Desist from offering architectural services in the State of Florida was issued along with the requirement that Mr. Martin sign an affidavit stating he will not offer or provide architectural services in the State of Florida. If Mr. Martin fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

Abraham Mathew Case No.: 2024-065510

Probable cause was not found that Abraham Mathew had signed and sealed drawings for an addition to his residence from a company based in Isarel which contained the seal of an architect that had no knowledge of the project and did not seal the drawings. A Closing Order was issued.

Javier Mayol, Sr. JM Drafting Services Case No.: 2025-052106 2025-052111

Probable cause was found that Javier Mayol, Sr. and JM Drafting Services of Thonotosassa, FL, are not licensed to practice architecture in Florida and are offering architectural services on a yard sign. A Notice and Order to Cease and Desist from offering architectural services in the State of Florida was issued along with the requirement that Mr. Mayol sign an affidavit stating he will not offer or provide architectural services in the State of Florida. If Mr. Mayol fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

John Miller Focus Estimating Case No.: 2025-053851 2025-053856

Probable cause was found that John Miller and Focus Estimating of Columbus, OH, are not licensed to practice architecture in Florida and are offering architectural services in an email solicitation. A Notice and Order to Cease and Desist from offering architectural services in the State of Florida was issued along with the requirement that Mr. Miller sign an affidavit stating he will not offer or provide architectural services in the State of Florida. If Mr. Miller fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

Christine Newton
Case No.: 2025-052915

Probable cause was not found that Christine Newton is using the title architect on her LinkedIn page. A Closing Order was issued.

Jael Ospina GB Drafting Design Case No.: 2025-060214 2025-060218

Probable cause was found that Jael Ospina and GB Drafting Design of Naples, FL, are not licensed to practice architecture in Florida and are contracting to provide signed and sealed drawings. The drawings are signed and sealed by an architect who is in an assisted living facility. An Administrative Complaint seeking fines will be filed.

#### Ian Ravago

Case No.: 2025-052122

Probable cause was found that Ian Ravago of Pikesville, MD, is not licensed to practice architecture in Florida and contracted to provide architectural services. An Administrative Complaint seeking fines will be filed.

Muhammad Sheraz Drafinity, LLC

Case No.: 2025-061988 2025-053674

Probable cause was found that Muhammad Sheraz and Drafinity, LLC of Albuquerque, NM, are not licensed to practice architecture in Florida and are offering architectural services in an email solicitation. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Mr. Sheraz sign an affidavit stating he will not offer or provide architectural services in the State of Florida. If Mr. Sheraz fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

Swati Srivastava The BIM Engineers Case No.: 2025-053654 2025-053646

Probable cause was found that Swati Srivastava and The BIM Engineers of Dallas, TX, are not licensed to practice architecture in Florida and are offering architectural services in an email solicitation. A Notice and Order to Cease and Desist from offering architectural services in the State of Florida was issued along with the requirement that Mr. Srivastava sign an affidavit stating he will not offer or provide architectural services in the State of Florida. If Mr. Srivastava fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

Paul Stonn Victory Homes Case No.: 2025-058755 2025-058765

Probable cause was found that Paul Stonn and Victory Homes of San Francisco, CA, are not licensed to practice architecture in Florida and contracting to provide signed and sealed drawings and is using the license number of another without his consent. An Administrative Complaint seeking fines will be filed.

Juan Manuel Vasquez Dickson Vaquez Civil LLC Case No.: 2025-052344 2025-052349

Probable cause was not found that Juan Manuel Vasquez Dickson and Vaquez Civil LLC are offering architectural services on their web site. A Closing Order was issued.

**Yeg Infill – Sherizad Interiors** 

Case No.: 2025-042699

Probable cause was found that Yeg Infill - Sherizad Interiors of Edmonton, Canada, is not licensed to practice architecture in Florida and is offering architectural services on their website. A Notice and Order to Cease and Desist from offering architectural services was issued along with the requirement that Ms. Hammoud sign an affidavit stating they will not offer or provide architectural services in the State of Florida. If Ms. Hammoud fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

Marilyn Zak Williams Estimating Case No.: 2025-053811 2025-053822

Probable cause was found that Marilyn Zak and Williams Estimating are not licensed to practice architecture in Florida and are offering architectural services in an email solicitation. A Notice and Order to Cease and Desist from offering architectural services in the State of Florida was issued along with the requirement that Ms. Zak sign an affidavit stating she will not offer or provide architectural services in the State of Florida. If Ms. Zak fails to return the affidavit, an Administrative Complaint seeking fines will be filed.

# II. <u>Licensed Cases</u>

Ramon Collado Case No. 2025-059750

Probable cause was found that Ramon Collado of South Miami, FL, a Florida licensed architect, failed to comply with the terms of two Final Orders. Further, Mr. Collado is practicing architecture while his license is suspended. An Administrative Complaint seeking discipline will be filed.

Richard Donoghue Case No. 2025-055144

Probable cause was found that Richard Donoghue of Dunedin, FL, a Florida licensed architect, is aiding and abetting an unlicensed firm that is offering and providing architectural services An Administrative Complaint seeking discipline will be filed.

Molly Grup Case No. 2025-059376

Probable cause was found that Molly Grup of Naples, FL, a Florida licensed interior designer, failed to comply with the terms of a Final Order. An Administrative Complaint seeking discipline will be filed.

# Helen Liptak Case No. 2025-059372

Probable cause was found that Helen Liptak of Lemont, IL, a Florida licensed architect, failed to comply with the terms of a Final Order. An Administrative Complaint seeking discipline will be filed.

### Keith Todoroff Case No. 2024-062757

Probable cause was found that Keith Todoroff of Sarasota, FL, a Florida licensed architect, affirmed at renewal that he had completed the required continuing education credits. Mr. Todoroff was chosen for the audit and did not provide any hours of continuing education during the audit period. An Administrative Complaint seeking discipline will be filed.

# Reinaldo Vera Case No. 2025-059395

Probable cause was found that Reinaldo Vera of Miami, FL, a Florida licensed architect, failed to comply with the terms of a Final Order. An Administrative Complaint seeking discipline will be filed.
